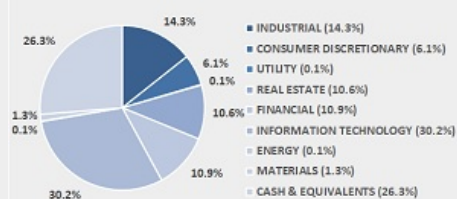
FUND INVESTMENT OBJECTIVE

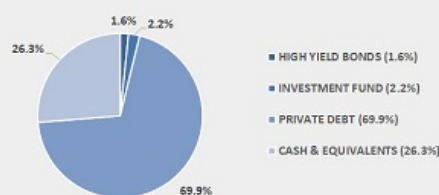
